Faculty Council & Senate Bill 37

With the passage of Senate Bill 37, all faculty councils in Texas must comply with Education Code Section 51.3522 by September 1, 2025. While the law formally designates faculty councils as advisory, Dr. Matkin has reaffirmed his commitment to shared governance and to preserving the strong tradition we have built together. Faculty Council's legitimacy as the voice of Collin College's teaching faculty remains intact.

To ensure compliance with SB 37, the Faculty Council Policy Committee worked with Dr. Johnson this summer to draft new Board of Trustees policy recommendations, presented for a first reading on August 8 and scheduled for a second reading on August 26. At the same time, the Faculty Council Procedures & Nominations Committee is updating our internal Procedures Manual to reflect the new requirements. These changes are structural in nature and align only with what the law requires.

Faculty Council operations will continue as usual with a few procedural adjustments, and we will keep you updated throughout the process. In short, we are on track, and we are going to be just fine.

Important updates for faculty

Faculty Ranks

The 2025–2026 Faculty Rank Letter of Intent is now live in Workday. All regular full-time faculty (excluding Temporary Full-Time) must submit the Letter of Intent by **11:00 p.m. on Monday, September 2, 2025**, even if you don't plan to apply for Faculty Rank this year.

The Portfolio Builder will be available beginning Monday, September 8, 2025. If you have your documentation and narrative already prepared, we urge you to submit your portfolios as soon as possible.

In the meantime, there will be a series of Faculty Ranks Portfolio workshops this semester designed to help you build your application portfolios. For more information on these workshops and much more concerning Faculty Ranks, please visit the [Faculty Ranks website](#).

A revamped Faculty Annual Appraisal?

The Faculty Annual Appraisal Revamp Committee collaborated this summer to create suggested updates to the faculty annual appraisal. The group consists of full-time faculty and administrators working to finetune the faculty appraisal for increased alignment, reflection, and support. The new appraisal provides detailed instructions, reflective questions, and examples to help faculty showcase their efforts throughout the year. This fall, the Faculty Annual Appraisal Revamp Committee will continue their efforts to finalize the appraisal before testing in Workday begins. Appraisal self-assessments are expected to launch in March, along with a schedule of training sessions. Please watch for further communication.

New Student Survey of Instruction (SSI) launching Fall 2025

Thanks to faculty feedback, Faculty Council and Dr. Abe Johnson (SVPCO) brought together a group of faculty and associate deans to rework the Student Survey of Instruction (SSI). Over the past two years, this task force has partnered with the Institutional Research Office (IRO) and piloted a new version of the survey in Fall 2024 and Spring 2025 with around 70 faculty. The updated SSI focuses on five key areas: course expectations, instructor communication, feedback, coursework, and encouragement to participate. It now uses a five-point scale with a neutral option, and students can leave comments after each question. Pilot results showed the new version is more reliable, more useful, and just plain better. Starting in Fall 2025, all course sections will use this updated SSI. The rest of the process will stay the same. If you have questions, email Faculty Council at fc@collin.edu.

Sabbatical Applications

Now through September 12, eligible full-time employees may submit applications for sabbatical during Fall 2026 and/or Spring 2027. An informational video, application packet, and timeline are accessible on the [Sabbatical webpage](#).

Voluntary Collin Invests 403(b) Retirement Savings Plan Update

Over the fall months, Collin College will transition from Corebridge to TIAA as our retirement provider. We are working closely with TIAA to determine an effective date. Communication with detailed information will be provided in advance before your first deduction is placed with TIAA. This will be done automatically so no action will be required. You will have the opportunity to make any changes after your funds have been moved to TIAA. This transition will include the opportunity to invest in a Roth 403(b).

Optional Retirement Plan (ORP) Update

Collin College's ORP Plan will undergo a modernization in the new fiscal year that will result in cost-saving enhancements. It will reduce the number of vendors to the Texas-mandated minimum of four which are listed below:

- Aspire-PCS (includes ISC Group and Lincoln Investment)
- Corebridge
- TIAA
- Voya

Once an effective date is determined, more detailed information will be provided to help you with your decision making for those that will be required to change providers as well as for those that may choose to make a change. All new deductions will go under the updated plans. You will not be required to move your current funds, but the cost savings will be worth considering in making this transfer.

New Standard Operating Procedures (SOP)

The Faculty Council partnered with administration last year to clarify and update Standard Operating Procedures (SOPs) that impact faculty. Two new SOPs have recently been added to the CougarWeb widget:

- Canvas Course Visitation SOP
- SOP for Priority Order of Teaching Loads and Overloads

The SOP widget is available to all faculty, staff, and administrators. More procedures will be added soon to promote consistency and transparency across the district.

Cell phone use in dual credit classrooms

House Bill 1481 now requires public school districts to ban or restrict cell phones and personal devices during the school day. For dual credit faculty teaching at high school campuses, this impacts the use of Canvas since students typically log in through OneLog-in. Collin College IT has developed a solution that removes the need for dual credit students on ISD campuses to complete the authentication process when accessing Collin resources. This will be in place by the first day of Collin classes on August 25, 2025. If students encounter issues on the first day, contact Craig Leverette, Vice President of Academic Operations, at cleverette@collin.edu.

Note: Multi-Factor Authentication will still be required if students access Collin resources outside the ISD network (such as on a Collin campus) or use a VPN/proxy while on the ISD network.

Syllabus updates for 2025-2026 AY

Current Political Climate and Challenges for Higher Education

A key theme from AGS meetings last spring was that higher education is facing heightened public scrutiny. This includes close examination of our work by external groups, some of which are openly critical of colleges and universities. Materials such as course syllabi, which are often publicly accessible, are among the most visible representations of our academic work and are frequently reviewed by those outside the institution.

Given this reality, faculty are encouraged to treat the syllabus as a professional document that serves as both a roadmap for student success and a public reflection of our academic integrity. This means focusing on policies and information that directly support student learning, clarify expectations, and align with institutional and legal requirements. Faculty are also advised to avoid including personal viewpoints, political statements, or ideological language that could distract from the syllabus's primary purpose of guiding students toward success in the course.

By ensuring syllabi remain clear, concise, and student focused, we can better safeguard academic freedom while also meeting our responsibility to present a professional and inclusive learning environment.

Concourse Syllabus Template Updates

In your courses, you will find a new concourse syllabus template. It will have several new headings for you to use. Please do not delete these headings. This is an effort across the district to have all syllabi look consistent, making it easier for students.

Please do not copy your entire syllabus over from a previous course. This will delete these new headings. You can copy and paste sections into one new syllabus, then copy the new syllabus over to other sections.

- **Course Information:** These two sections will show your course information, including the dates of the term, class meeting time, and location. If your class is a hybrid or online class, it will note this under Course Description.
- **Contact Information:** Do not delete any of the red subheadings. Only delete the recommendations in light blue under email address, phone number, and office hours. Leave the note about email communications at the bottom.
- **Course Policies:** Below are the new subheadings. Keep these in this order. If a subheading does not apply to your class, we recommend adding “none.”
 - o Attendance/Participation
 - o Assignment Submission Requirements
 - o Late Work/Missed Assignments & Assessments
 - o Technology Expectations

- o Classroom Civility/Netiquette
- o Accommodations (pre-populated)
- o Scholastic Dishonesty
- o Artificial Intelligence (faculty can choose from several options)

Pregnant and Parenting Students

The Concourse syllabus template now includes an updated section on Pregnant and Parenting Students in accordance with Title IX and Texas Education Code Section 51.982. This statement outlines the college's process for providing reasonable modifications and leave of absence requests for students who are pregnant, experiencing a pregnancy-related condition, and/or parenting.

Faculty are encouraged to review the updated language in the Concourse template and direct students to the [Pregnant and Parenting Students webpage](#) or to contact the college's liaison officer at 972.599.3126 or athroop@collin.edu for assistance.

Religious Holy Days

The Concourse syllabus template now includes updated language on Religious Holy Days in accordance with Section 51.911 of the Texas Education Code. Students observing a religious holy day may take an exam or complete an assignment scheduled for that day within a reasonable time, provided they submit a written request to each professor before the course census date. Faculty should direct students to the [Notification of Absence Form](#) and remind them that additional information is available through Student and Enrollment Services on any campus.

- Find the case you want to update and click “View Case Details.”
- In the left-hand menu, click “Modify Details.”
- From there, you can attach files or make updates as needed.

Faculty Accolades...

- **Prof. Larry Stern (Sociology, Plano)** – Prof. Stern has been named a Professor Emeritus of Collin College. The Professor Emeritus Program recognizes faculty members who have dedicated a substantial part of their careers to Collin College and its students, while also providing a way for the College to continue benefiting from their expertise.
- **Prof. Sofya Antonova (Mathematics, Plano)** – Prof. Antonova has been named to the Sam E. Roach Endowed Chair in Business and Engineering. Established in 2013, the chair honors long-serving Trustee Sam E. Roach for his leadership and commitment to Collin College and the community and recognizes exceptional teaching in business or engineering fields.
- **Prof. Amy Bierup (RN Nursing)** – Prof. Bierup has been named to the Florence Marie Dickinson Endowed Chair in Nursing. Established through a gift from Richard R. Dickinson and his wife Barbara in honor of Mr. Dickinson's mother, the chair recognizes exceptional teaching in nursing.
- **Prof. Courtenay C. Jauregui (Education, iCollin)** – Prof. Jauregui has been named to the Lebrecht Endowed Chair for Scholarly and Civic Engagement. Established in 2005 through a gift from business and civic leader Royden Lebrecht, this chair recognizes outstanding contributions in scholarly and civic engagement.
- **Dr. Jason Snyder (Mathematics, McKinney)** – Dr. Snyder has been awarded the George Pólya Award from the Mathematical Association of America (MAA) for his article, “A Modern Spin on Archimedes’ Quadrature of the Parabola,” published in The College Mathematics Journal. The George Pólya Award is presented annually by the Mathematical Association of America (MAA) for articles of expository excellence. The award was established in 1976, and only up to two are given yearly.
- **Prof. Danielle Bramall (Mathematics, Frisco)** – Prof. Bramall was selected as a fellow in AMATYC’s (American Mathematical Association of Two-Year Colleges) Project ACCCESS program, a national initiative designed to support early-career community college math faculty. She is the sixth math faculty member from Collin College to receive this distinction in 22 years. Through this fellowship, Prof. Bramall will have opportunities for research and collaboration with colleagues in math education at the national level.
- **Dr. Khimen Cooper (ENGL, Plano)** – Dr. Cooper was selected to speak at TEDxPlano 2025 held at the Robinson Fine Arts Center on June 26. Dr. Cooper’s presentation was titled “To Live a Life with Intent, You Must First Learn to Think with Intent.”
- **Prof. Russell Smith (Animation and Gaming, Frisco)** – Prof. Smith was selected to participate in the next Leadership Wylie Class XXII.
- **Prof. Brandy Jumper (Mathematics, McKinney)** – Prof. Jumper has been awarded the Phi Theta Kappa’s Continued Excellence Award for Advisors. This award recognizes advisors who have previously received the Distinguished Advisor Award and continue to make significant contributions to their chapter and the organization.
