- 4. Vice President's Report George Jackson
 - TCCTA convention coming up next week in Dallas opportunity for professional development
- 5. President's Report:
 - Faculty Incentives waiting on approval, delayed due to presidential search
 - Contract Date and Leave without pay waiting on approval, delayed due to presidential search
 - Chair model update waiting on approval, delayed due to presidential search; possibly looking for broader approach to finding a way to adjust the chair framework to accommodate college growth without creating more administration and allowing deans to have broader focus, more even workloads amongst chairs and amongst deans; faculty input has been requested by Pres. Rasmussen and VPPs are open to input later on in the process; discipline leads may be impacted too but unsure yet because it's early on in the process; no specific time frame involved
 - HR questions delayed but expected from Kim Davison soon
 - Open source course materials discussion in Leadership Team about future of open source course materials, may want to have district-wide committee to discuss and explore this idea
 - Guns on campus Texas Senate committee approved two bills (SB 11 and SB 17) to allow people with CHL to carry on campus, but that bill has not yet made it all the way through the legislative process; if interested in this process, write your legislator
 - Restructure CAM (Communications Advisory Meeting) goal is to reduce the number of people on committee to allow committee to take more action
 - Email for withdrawals after census date IT trying to set up system to generate an email to faculty, notifying us if a student withdraws from our class

- Title IX and Violence Against Women Act student training students have been contacted to complete training (30 minutes), will be hold on registration if they don't complete it
- Degree planning software for our Quality Enhancement Plan (QEP) to improve advising; software would allow students to plan out their courses over the next several semesters
- Search for new district president Application deadline was December 15th, 2014; Board of Trustees chose 7 candidates to interview and have now chosen 2 finalists whose CVs and cover letters are up on the college website; faculty submitted over 150 questions for Board of Trustees to consider for question and answer sessions to be conducted the week of February 16th for faculty and staff to attend on each campus; of 150 questions submitted, 10 will be selected to be answered at each campus (so 30 in total); first hour of each session will be for Q&A, then last half hour would be for less formal "mingling" with candidates; a survey will be sent out very shortly after the sessions with a tight turnaround time, so please watch your email for that survey; potentially a final candidate could be chosen soon after and hired some time in March 2015
 - Faculty inquired if meetings could be posted online for faculty to view sessions they cannot attend
- Faculty Council will try to do a candidate forum for candidates running for the Board of Trustees at our April Faculty Council meeting; will call for questions in March
