### 2. Approval of September 25, 2015 Minutes: Motion to accept the minutes as distributed (Balch, Jackson), passed unanimously

- **3. Treasurer's Report:** \$102.05 in Sunshine fund, \$1471 for scholarships, ~\$11,000 contributed in the Lift Up program.
- **4. Vice President's Report:** Committee of the Whole will be meeting four times per year instead of three times per year.

# 5. President's Report:

- Dr. Matkin will be coming to address the remainder of the HR questions in November meeting.
- COTW Briefings
  - Study Abroad re-establishment Dean Weasenforth and faculty are working on a proposal that will come forth in spring.
  - o Director of First Impressions Event -
  - There were 335 college employees in attendance including, front staff and others who are first line for student interaction. The event included brunch, a workshop, and presentation of thank you gifts. The first of its kind at Collin, the event was hosted by the Human Resources department and President Matkin and was held to both inform and honor staff for their ongoing efforts in serving students.
  - Workshop presenter, Dr. Arlene Arnsberger, spoke of how staff can work to put students first. Points brought up: students are more likely to stay in college if they are engaged. The college has about three weeks to make an impression on students so that they feel welcomed and persist in their academic goals.
  - In an effort to inform faculty members more specifically as to Dr. Arnsberger's research, FC might host focus groups with students sharing their stories.
  - Powerful event with great impact, well received, and will likely be held again in the future.
  - Dr. Scott Parke hired as VP of Policy and Planning. Board Policy project
  - HR and Dr. Parke's team will be looking at every line of every policy. Starting with personnel policies. Former group that looked at college policies might be reinstituted for this process. First policy that is being considered is DEC (Local) Compensation & Benefits, Leaves & Absences. Three personal days starting in January will be considered at the October Board of Trustees meeting for the first reading of the revised DEC (LOCAL).
  - Chief of Police 37 applications.
  - o All College Day, January 2016
    - Division meetings will include some element of strategic planning.
    - August ACD will be Friday, Aug. 12.

- Innovation Challenge 14 submissions received, emphasis that timeliness and transparency is important. Committee formed to review the submissions. Hughes will serve on this committee.
- o Conceal & Carry
  - Hughes asked to defer this discussion until the Chief of Police is hired.
  - There will be a meeting between Dr. Matkin, Dr. Kihl, Mr. Ken Lynn, and faculty will meet to discuss how to proceed and prepare for compliance of the law. The law will be enforced on public universities beginning Aug. 1, 2016 and Aug. 1, 2017 at two-year public colleges.
  - Emergency Preparedness Plan
  - How do we mediate situations that arise?
- Distance Learning Committee update Kimberly Harris is chairing this committee with 18 faculty, cross-discipline, cross-campus, will be addressing the broad scope.
- Campus Representatives meetings
  - Hughes met with campus reps at CPC and PRC. Very helpful to get a sense of the different dynamics. Meeting with SCC reps to come. Intent is to provide more opportunities for input.
- Survey Monkey results meeting with Tom Martin in the coming weeks to analyze the data collected.
- Board of Trustees meeting October 27, first reading of DEC (Local) Compensation & Benefits, Leaves & Absences

  - Interest in creating a survey. Will be drafting something to bring to Faculty Council.
  - Open process, need as much input as possible.
- **Committee on Faculty Council Procedures and Nominations –** Dan Lipscomb
  - Looked at the proportionality representation by campus, the current numbers look good.
    - If we expand to 20 members, the numbers don't look as good.
    - If we expand to 22 members, CPC and PRC would be slightly underrepresented. SCC would be slightly overrepresented.
    - The best combination is with a 25-member body.

# Teaching and Learning Report to Faculty Council 10-23-2015

On October 14, T and L sent a Survey Monkey requesting faculty subcommittee participation with an additional request on October 20<sup>th</sup>. From those two requests, we received 69 willing participants, with several people committing service to more than one subcommittee.

- 1. I have sent the eight subcommittee member lists out to the following people: 1) those who offered to serve as chairs 2) entire subcommittees with a request for someone to step up and take a leadership position. Fourteen people volunteered for the "Lab/Support Staff" subcommittee, with seven people offering to take a lead position. I will send that information to all members on all three campuses with suggested options as to how this group might select a chair or co-chairs, perhaps one lead at each campus. Also, this specific group will be asked to clarify their goals and to provide examples of concerns.
- 2. Each subcommittee received the following requests: 1) to form a clearly stated mission statement 2) to send meeting dates and minutes to Marti Miles-Rosenfield and Cindy Briggs 3) to post meeting dates and locations on the Teaching and Learning calendar 4) to represent the Collin College faculty in a professional manner 5) to encourage discussion of ideas and issues with members of the Faculty Council 6) to bring forth, in writing, any proposed suggestions and/or actions by sending information either to the Teaching and Learning co-chairs or to the President or Vice-President of Faculty Council.

- 3. Each subcommittee member also received the following invitation to present a session at the January 2016 Faculty Development Day Conference on Friday, January 8<sup>th</sup>. Judy James originally sent this request for proposals on 9/28, but I sent it again today in hopes more people will become interested in making presentations in the interest-are of their subcommittees.
- 4. The proposed timeline below may assist with the formation of strong, cohesive groups, operating efficiently and posting updates on the Teaching and Learning website so that ALL faculty may benefit from their findings.
