RESOLUTION:

PROPOSED COLLIN COLLEGE CAMPUS CARRY POLICY

Whereas, since, the fall of 2015, a subcommittee of the Faculty Council Campus Carry Committee has been monitoring developments regarding implementation of Senate Bill 11 (the "campus carry" law) at public four-year institutions in Texas and;

Whereas the subcommittee made initial contacts with faculty leaders at the fouryear institutions in the 2015-2016 academic year, and then followed up this fall when the campus carry policies of those institutions had been finalized and;

Whereas the subcommittee contacted the 33 following four-year institutions: Angelo State University, Lamar University, Midwestern State University, Prairie View A&M University, Sam Houston State University Stephen F. Austin University, Sul Ross State University, Tarleton State University, Texas A&M University – College Station, Texas A&M University – Central Texas, Texas A&M University – Commerce, Texas A&M University – Corpus Christi, Texas A&M International University, Texas A&M University – Kingsville, Texas A&M University – San Antonio, Texas A&M University – Texarkana, Texas Southern University, Texas State University, Texas Tech University, Texas Women's University, University of Houston – Clearlake, University of Houston – Downtown, University of Houston – Victoria, University of North Texas, University of Texas at Arlington, University of Texas at Austin, University of Texas at Dallas, University of Texas at El Paso, University of Texas at Permian Basin, University of Texas at Rio Grande, University of Texas at San Antonio, University of Texas at Tyler, West Texas A&M University and:

Whereas the subcommittee met to formulate policy recommendations for Collin College based on the "best practices" of the four- year colleges researched in the state, therefore:

The subcommittee asks the Faculty Council to forward the following recommendation to Collin College President Dr. Neil Matkin:

That the president appoint a permanent Campus Carry Committee that includes representatives of the administration, two faculty members from the Spring Creek, Preston Ridge, and Central Park campuses, staff members, representatives of the student government, and students from the police academy;

That the following methods be used to gain feedback from the college community regarding Collin College's Campus Carry Policy:

1. Anonymous surveys designed to protect the identity of respondents should be made available to Collin College students, faculty, and staff no later than February 2017; that the survey allow respondents to indicate preferences regarding gun exclusion zones, and also include open-ended questions that allow feedback on how the campus community feels about the state's campus carry law and other issues related to the law; and that these surveys be conducted in the early spring and be conducted subsequently every two years;

2. A dedicated email address that the campus community can use to make suggestions, express concern, or pose questions about the college's campus carry policies and that the comments should forwarded to the college administration;

3. Forums sponsored by the Faculty Council open to the entire Collin College community at the Preston Ridge, Central Park, and Spring Creek campuses and that these forums begin no later than early February 2017 and that the forums be video-recorded, with the videos posted on a new Collin College Campus Carry webpage.

That Collin College exclude guns from the following areas:

- Stadiums, and other sports facilities where intercollegiate and other sports activities will take place
- Counseling Centers and Other Mental Health Facilities

- Premises for Events Involving Minors and Classes and Daycare Facilities Involving Minors
- Laboratories with Volatile Chemicals
- Premises Where Student, Staff, or Faculty Disciplinary Hearings are Being Held
- Polling Places
- Premises leased by a 3rd Party that has requested the exclusion of Guns, including Dining Facilities
- Gymnasiums, Physical Education. Facilities, Tennis Courts, and Locker Rooms
- Premises Used by Groups Holding Religious Services.
- Testing Centers
- Any Special Event Where Alcohol is Being Served
- Police Facilities
- Emergency Locations
- Solely Occupied Offices Where The Occupant Has Given Oral Notification in Addition to Signage
- Large scale events
- Bursar's And Accounts Receivable Offices
- Campus Residences
- Faculty Offices Occupied by Faculty Who Have Filed a SOBI Complaint with the Administration upon the Request of the Faculty Member

That Collin College should not provide lockers for gun storage and;

That Collin College create a Campus Carry Information webpage that includes information on Senate Bill 11, the college's policy, a history of how the policy was formed, frequently asked questions, an instructional video that explains the policy and where guns are excluded, the dedicated comments email address, and videos of the campus's open forums on guns;

That Collin College's campus carry policy should be reviewed by a permanent Campus Carry Committee annually to allow the college to change policy based on new laws passed by the Texas State Legislature, legal decisions by state and federal courts, and experience in the previous year regarding enforcement and implementation of the law.

Finally, that the Faculty Council formulate a required syllabus statement to be used by all faculty members.

Intellectual Property Proposal

Whereas it is in the interest of the students, faculty, administration, and taxpayers that Collin College faculty produce original scholarly research, articles, monographs, textbooks, works of art, inventions, films, television productions, patents, and other works and;

Whereas such works enhance the reputation of the Collin College and the experience gained producing these works enhances the knowledge and skill that Collin County faculty bring to the classroom and;

Therefore Collin College should enact a policy that encourages faculty scholarship, inventiveness, and innovation;

Be it resolved that Collin College adopt the following policy on Intellectual Property Rights which brings this institution in line with peer institutions such as San Jacinto College, Austin Community College, Lone Star College, and Alamo College:

PROPOSED INTELLECTUAL PROPERTY RIGHTS AT COLLIN COLLEGE

Intellectual Property

This policy governs the ownership of Intellectual Property produced by faculty, staff, and students of Collin County Community College District.

In order to promote the creation of creative and original work, all Personal and Scholarly Works produced by Faculty, Staff, or Students inclusive of incidental use of College resources remains the Intellectual Property of the creator(s). An exception is Works that are produced for the college as a scope of the employment when specifically requested to create the Work, or directly commissioned by the College. The college retains copyright of materials produced within an employee's scope of employment or in which Collin College supplies or equipment played a dominant role.

Definitions:

Intellectual Property refers to inventions, discoveries, patents, patent applications, scientific or technological developments as well as copyrightable instructional materials such as books, articles, artistic works, movies, and television programs.

Incidental Use is defined as utilizing resources commonly encountered in the course of one's daily job. This includes, but is not limited to, one's office, office computer, telephone, library resources and other college resources.

Scholarly Works are defined as Works that are created to further scholarly or artistic activity. These include but are not limited to manuscripts, scholarly articles, documentaries, websites, monographs, works of art, and other research based productions.

Personal Work is defined as Intellectual Property that is created and unrelated to the creator's responsibilities to the College.

Proposed Anti-Racism Resolution

Whereas, the Southern Poverty Law Center reported nearly 869 "hate incidents" after the presidential election as of November 29 and 140 have taken place at colleges and universities, and another 183 at public schools and;

Whereas, racist fliers were posted at the Spring Creek, Central Park, and Preston Ridge campuses in the wake of the recent national election, and;

Whereas racist graffiti was drawn in chalk on the campus of Plano East High School and a young woman wearing a hijab at that campus was bullied, and;

Whereas fliers were placed on the doorsteps of residents of the Craig Ranch neighborhood in McKinney. which, according to a local television station, called for the country to "get rid of Muslims, Indians, Blacks, and Jews," telling residents of that neighborhood to not sell or rent their homes to those groups, and warning that, "We are everywhere and watching every move," and;

Whereas on November 29 Collin College President Neil Matkin issued the following statement in response to incidents at this institution: "It is the mission of Collin College to be a student and community-centered institution committed to developing skills, strengthening character, and challenging the intellect. We believe that higher education has a profound duty to expand wealth of knowledge, empower critical thinking, and create a safe environment to expand learning beyond the invisible silos of typical experience. Collin College welcomes and celebrates faculty, staff, and students from all backgrounds and cultures regardless of similarities or differences. In fact, it is a baseline expectation that the people of our college community uphold the Core Values of Collin

College and honor each other with respect and mutual deference for the common good. By embracing our diversity, we become stronger, wiser, and better equipped to conquer the challenges ahead together."

And whereas, the Faculty Council fully supports Dr. Matkin's statement,

be it resolved that:

The Faculty Council condemns these recent acts of intimidation motivated by racism, anti-Semitism, xenophobia, and Islamophia as an affront to the deeply-held founding principles of Collin College; that the faculty of Collin College believes that diversity is a strength, not a weakness; that we believe in a fundamental right to education for all, and that our students should expect that they can learn here in an atmosphere of respect and tolerance; that this faculty is committed to welcoming all regardless of race, nationality, creed, sexual orientation, gender identity, and immigration or disability status; and that, as a faculty, we believe, in the words of Martin Luther King, Jr., that injustice towards one is injustice towards all. We furthermore stand resolutely against intolerance and discrimination and will insist on a classroom atmosphere in which all are treated with dignity and encourage all faculty to express these principles to their students, and;

Be it furthermore resolved that the following statement to be included in the generic syllabi for all courses at Collin College:

"Collin College prohibits discrimination, including harassment, against any student on the basis of race, color, religion, sex, national origin, disability, veteran status, or on any other basis prohibited by law. Retaliation against anyone involved in the complaint process is a violation of Collin College policy and is prohibited. Discrimination against a student is defined as conduct directed at a student on the basis of race, color, religion, sex, national origin, disability, veteran status, or on any other basis prohibited by law, that adversely affects the student."
