Dr. Sherry Linkon



Dr. Sherry Linkon is Professor of English and Faculty Director of Writing Curriculum Initiatives in the Department of English at Georgetown University. Her research areas focus on Working-Class Studies and scholarship of teaching and learning. In Working-Class Studies, much of her work explores the cultural meaning and social costs of deindustrialization. She is currently working on a study of contemporary American literature that reflects the continuing influence of deindustrialization on working-class people and their communities.

Dr. Linkon's research and writing also focus on teaching about social class and supporting working-class students in higher education, as well as students' learning in the humanities. She has written about students' struggles with interdisciplinary analysis. While her publications are too numerous to list here, they include Literary Learning: Teaching in the English Major, Teaching Working Class, and her books with co-author John Russo, New Working-Class Studies and Steeltown USA: Work in Memory in Youngstown.

Ruth A. Allen Pioneer in Texas Working-Class History Lecture

Dr. James C. Maroney



James C. Maroney is retired from Lee College in Baytown, Texas, where he taught for 44 years. He previously taught at Sam Houston State University, Amarillo College and as a teaching fellow at Sam Houston and the University of Houston. He holds BA and MA degrees from Sam Houston and a PhD in history from the University of Houston.

Specializing in labor history and the progressive era, his publications include numerous articles in professional journals and books. Following closely upon the heels of the founding generation of Texas working- class historians, Dr. Maroney has written about the struggles of oil field workers, Gulf Coast longshoremen, Texas coal miners, and East Texas workers in general.

In 2013 he and co-editor Bruce A. Glasrud, published *Texas Labor History*, the first book to survey the literature on the Texas labor movement from the 1830s into the 1970s. He also has published on other historical topics, including the teaching of the US history survey.
